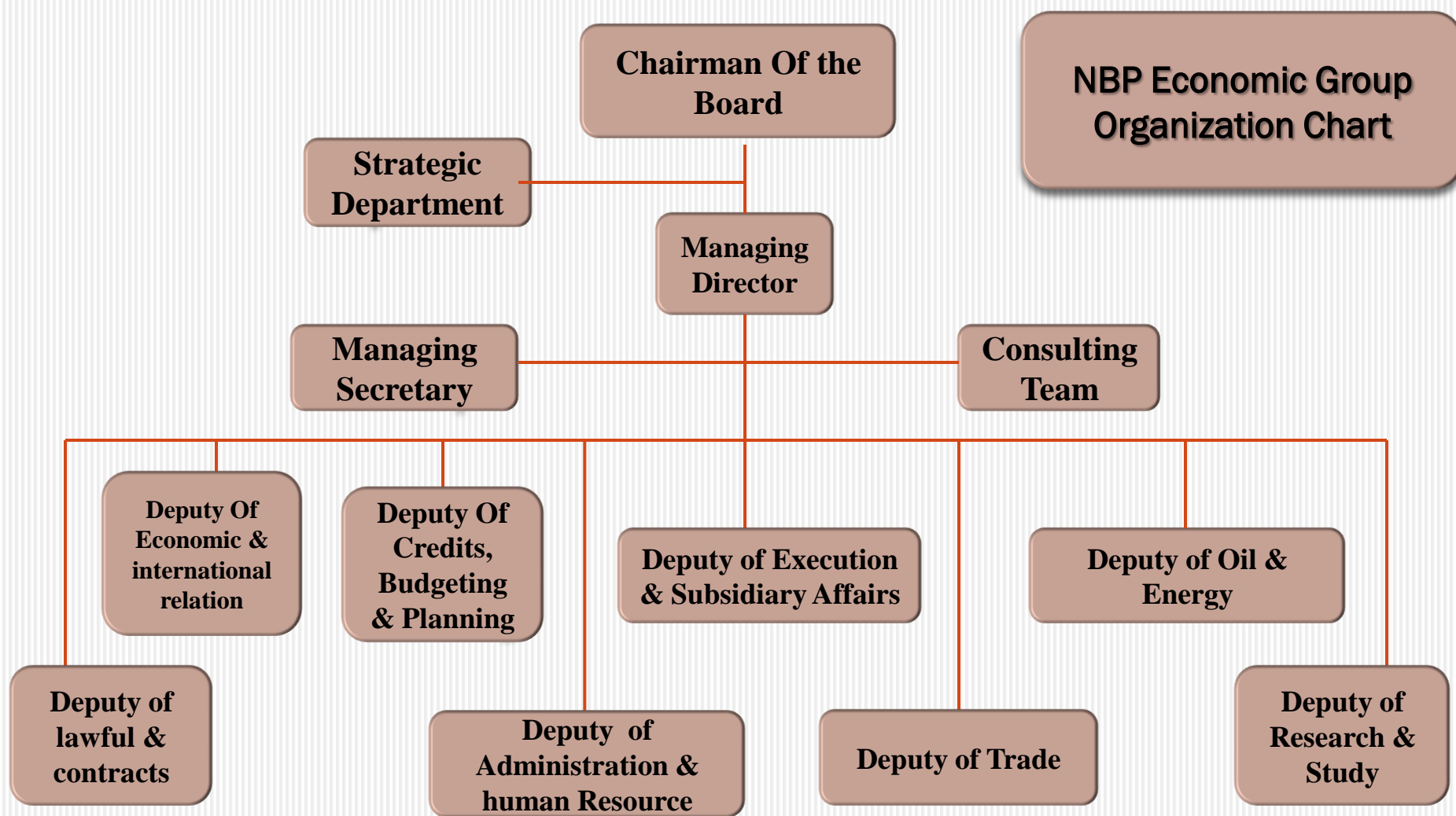
## Brief History

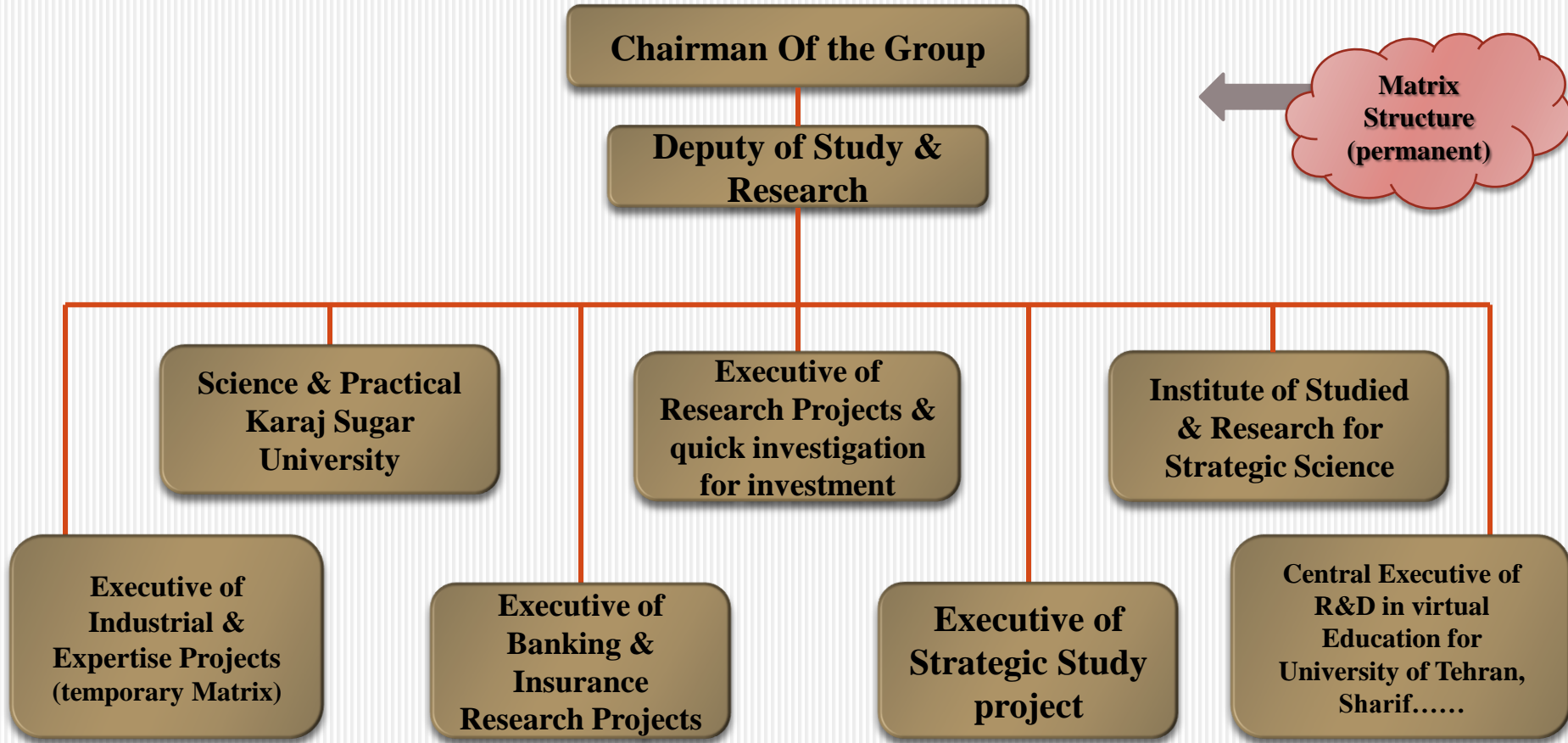




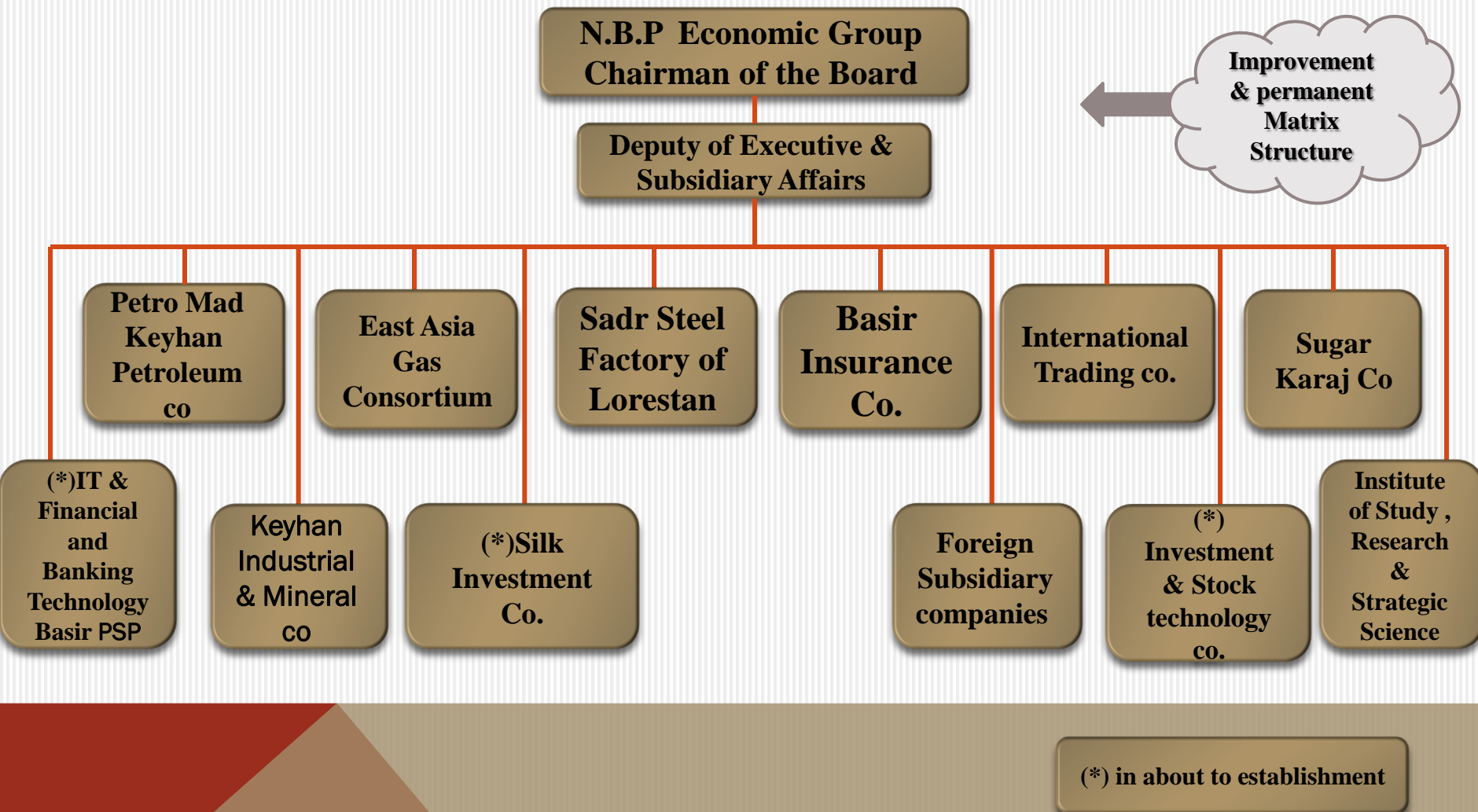
### **Directors' Assembly**
